Sanitation and Graffiti Removal
The OAA has a sanitation contract with CleanScapes. CleanScapes provides two uniformed street cleaning personnel from 7a.m. to 3p.m., six days a week; Zone 1 receives services six days a week. Zone 2 receives services three days a week. Workers sweep sidewalks, curbs, gutters and pressure wash sidewalks and MUNI-boarding islands, straighten newspaper racks and report incidents to 311. Graffiti Removal: CleanScapes also removes graffiti from public amenities and street furniture within 24 hours. Graffiti on private property is removed daily.

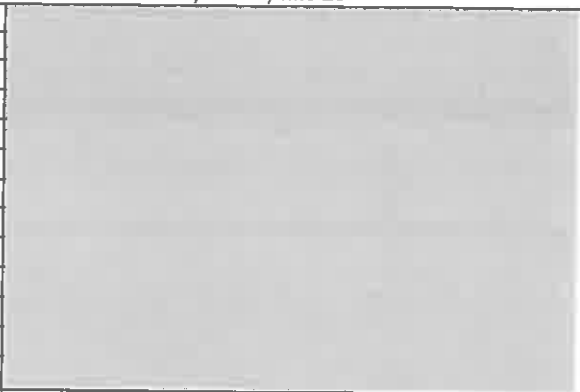
